



Sometimes called the multiple, P/E gives investors an idea of how much they are paying for a company's earning power. R squared measures how well an investment's returns correlate to an index. An R squared of 1.00 means the portfolio performance is 100% correlated to the index's, whereas a low r-squared means that the portfolio performance is less correlated to the index's. Return on equity (ROE) is the amount of net income returned as a percentage of shareholders equity. Sharpe ratio is a risk-adjusted measure calculated as the ratio of excess return to standard deviation. Standard deviation measures how widely individual performance returns, within a performance series, are dispersed from the average or mean value. Tracking error is the amount by which the performance of the portfolio differs from that of the benchmark. Upside/downside market capture measures annualized performance in up/down markets relative to the market
