## Global Strategist Portfolio

Investment Objective: Seeks above-average total return over a market cycle of three to five years.

Investment Approach: Using a top-down global macro strategy that is informed by deep bottom-up analysis of fundamental drivers, valuation and technicals the Portfolio Solutions Group focuses on global macro and thematic investments across stocks, bonds, currencies and commodities. The team invests in opportunities at the asset class, country, sector and thematic levels, rather than concentrating on individual security selection.

(2) Effective May 31, 2017 - The composition of the Customized Morgan Stanley Investment Management ("MSIM") Global Allocation Index, the secondary benchmark index of the Portfolio, has changed from 60% MSCI All Country World Index, 30% Bloomberg Global Aggregate Bond Index, 5% S&P GSCI Light Energy Index and 5% ICE BofA US Dollar 1-Month LIBID Average Index to 60% MSCI All Country World Index and 40% Bloomberg Global Aggregate Bond Index.

The Blended Index performance is a performance-linked benchmark of the old and new benchmark of the Portfolio, the old represented by 60% MSCI All-Country World Index, 30% Bloomberg Global Aggregate Bond Index, 5% S&P GSCI Light Energy Index and 5% ICE BofA US Dollar 1-Month LIBID Average Index from inception through May 31, 2017, and the new Blended Index which consists of 60% MSCI All-Country World Index and 40% Bloomberg Global Aggregate Bond Index for periods thereafter.
